The Commonwealth Secretariat Debt Recording and Management System (CS-DRMS), available in both English and French versions, is currently deployed in 64 countries within as well as outside the Commonwealth regions. The software is licensed free of charge to Commonwealth countries while other countries purchase the software through Crown Agents, the official distributor of CS-DRMS outside the Commonwealth.
